Subject: Bin Site Transition Plan – 2021 Annual Report

Recommendation

WHEREAS the Ministry of the Environment, Conservation and Parks (MECP) has mandated that The District Municipality of Muskoka (District) remove all unlicensed waste bin sites by 2023;

AND WHEREAS the District is required to submit an Annual Report outlining the progress made over 2021 as well a plan for transitioning unlicensed waste bin sites in 2022;

NOW THEREFORE BE IT RESOLVED THAT the 2021 Annual Report, Attachment A to Report PW-13-2021-1, **be approved and submitted** to the MECP by November 30, 2021;

AND THAT upon approval of the Annual Report by District Council and the MECP, staff **be directed** to initiate transition plans for 2022 as outlined within the Annual Report.

Origin

On June 14, 2019, the Ministry of the Environment, Conservation and Parks (MECP) formally directed The District Municipality of Muskoka (District) to remove/decommission all unlicensed bin sites by April 30, 2023 and, in addition, submit an abatement plan outlining the District's commitment/transition details for the four (4) year timeframe.

The Bin Site Transition – 2021 Work Plan, presented through <u>Report PW-2-2021-2</u> to the Engineering and Public Works (EPW) Committee on February 17, 2021 has been the basis of work undertaken by the Project Team and Project Consultant (GHD) this year to date. Additionally, discussion on alternative service provision was presented through <u>Report PW-10-2021-6</u> to the EPW Committee on August 18, 2021.

The purpose of this report is to present the draft Bin Site Transition – 2021 Annual Report (Attachment A) prepared by the Project Consultant, GHD, for review and comment prior to submission to the MECP by November 30, 2021.

Background

Each year through 2023, the District is working towards the transition of a portion of sites and, in addition, initiating communication with communities and assessing/ determining alternatives for sites to transition the following year. This is to be reported annually to the MECP until all sites are transitioned to alternate waste collection service.

As of the start of 2021, there were seventy-seven (77) sites in service (36 year-round, 28 summer, and 13 winter sites). The 2021 plan included a list of twenty-four (24) sites to transition and/or initiate discussion on servicing alternatives. In addition, two (2) additional sites in the Township of Muskoka Lakes (Bin Site 88 – Walker's Point Marina and Bin Site 85 – Muskoka Village Harbour Marina (Skeleton Lake)) were removed at the request of the hosts and temporary alternate servicing was implemented this summer and consultation initiated.

Operationally, monitoring of the sites in service continues throughout the District with additional staff and resources allocated to ensure inspections continue and illegal dumping is addressed as per commitments made to the MECP at the outset of the pandemic in spring 2020. Illegal dumping at sites continues to be problematic especially over the weekends and staff are reporting significant dumping on Sundays or Mondays after long weekends – even after sites have been attended to.

Analysis

The transition project continues to require significant resources to manage and move forward – both in staff time and budget. Learnings over 2021 to be applied in 2022 include:

- All sites require some form of discussion on servicing even sites that are
 transitioning to curbside collection. Residents require assistance, for example, in
 determining location of bear-proof bins, consultation is required with Area
 Municipalities to determine appropriate location(s) for common collection points, and
 program information must be supplied/explained to residents not accustomed to the
 curbside program or District waste facilities;
- Grouping sites together geographically to address as a "package" has been helpful (such as the east Lake Muskoka sites and Minett-area sites). The Project Team can focus on particular communities, study patterns of travel and usage in-depth, and determine consistent provision of service throughout the greater community; and
- Staff have begun community discussions regarding servicing of the various winter sites – noting that determining need and usage has been initially challenging. Winter bin sites have historically been put in place to service remote locations where there would be need for supporting year-round residents with significant drive times. The

challenge lies in that seasonal residents (those using their cottages on weekends or holidays, for example), have become accustomed to year-round service with the winter dumpsters. This discussion will be brought forward to the EPW Committee for direction in 2022 to determine a prudent and sustainable level of servicing.

2021 Accomplishments

Despite the on-going pandemic and impacts on waste management operations and resources, significant progress was made over 2021 on advancing transition of the bin sites. A more extensive description is provided in the GHD report but highlights include:

- Discussion on servicing continued in the following communities: Kahshe Lake, Lake Joseph (Foot's Bay area), Nine Mile Lake, Pine Island (Lake Muskoka), Prospect Lake, Lake Muskoka (east), Gull Lake and Silver Lake, Clearwater Lake, Riley Lake, Lake Rosseau (Minett), Lake Rosseau (Windermere), Skeleton Lake, and Georgian Bay.
- Five (5) community surveys were undertaken identified on Table 1 provided in Attachment B. Survey results are posted on EngageMuskoka. Details on the number of respondents, distribution, and associations that supported the surveys can be found in the GHD annual report.
- Lakeside Waste Collection continued as a result of the successful 2020 pilot program and was expanded to additional locations. Supervised, stationary collection vehicles were placed at landings for scheduled events every Sunday during the summer in the following locations:
 - Lake Joseph McDonald Road (Foot's Bay)
 - Skeleton Lake Public Launch at Skeleton Lake 3 Rd
 - Skeleton Lake Muskoka Village Harbour
 - Lake Rosseau Parker's Marina (Windermere)
 - Lake Muskoka Walker's Point Marina
 - Lake Muskoka Church Dock Road (Milford Bay)
- At the time of writing, works are also underway to plan a winter Lakeside Waste Collection pilot. Winter servicing in remote areas with significant drive times to existing waste facilities is proving challenging. Information from the winter pilot will be used to assess the viability of servicing communities where winter curbside collection cannot be facilitated.
- Seven (7) bin sites were removed in 2021 or have been identified for transition by the end of 2021, identified in Table 2 found in Attachment B.

Bin Site Transition Plans for 2022

Although the Project Team has developed processes and strategies for community discussion and input into alternate servicing, significant time is required to address each site and address residents' concerns and questions. Staff are cognisant, however, that the April 2023 deadline and commitments made to the MECP are imminent. This has influenced the work plan for 2022.

Tables 3 through 6 found in Attachment B outline the program for 2022. In summary:

- Fifteen (15) sites are proposed to transition to curbside or special landing collection throughout 2022 (occurring throughout the year to manage change);
- The Lakeside Waste Collection program will be expanded to include eleven (11) summer pick-up locations (considers the transition of fourteen (14) bin sites) (noting that this could be expanded to other locations based on need and discussion on pick-up spots);
- Advance/continue development of drop-off depots to support Riley Lake (Housey's Rapids depot), Go Home Lake, east Lake Muskoka (Browning Island), and Nine Mile Lake;
- Discussion on the bin site plan will be initiated at seven (7) sites continuing to address multiple sites in specific areas as outlined above; and
- Discussion on servicing alternatives and planned transition of eight (8) winter sites in fall 2022 in Muskoka Lakes and Bracebridge.

Summary

Bin sites are unauthorized by the province and the MECP has directed that all sites be removed from service by April 2023. In total, 19 of 88 sites will have transitioned by the end of 2021 noting that progress has been impacted by public resistance as well as the pandemic. The proposed plan for 2022 will see an additional 27 sites transitioned to alternative service leaving a remainder of 42 sites to address in 2023. It is anticipated that an extension to the April 2023 deadline will be requested from the MECP during the 2022 Annual Report which will require prior consultation with senior MECP staff. Public consultation will continue in 2022 for all remaining sites with a particular focus on the remaining sites in Muskoka Lakes, winter sites in Bracebridge, and Georgian Bay.

Financial Considerations

Costs (including staff and consulting time) associated with the transition project have totalled approximately \$309,521 to date, funded from the 2021 Solid Waste Management Capital Budget – project 450084, DMM Waste Management Strategy. The project is financed from the Solid Waste Capital reserve fund with a total budget of \$450,000.

In regard to additional alternative servicing, the following service level changes (SLCs) will be included in the 2022 Draft Budget for consideration:

- Lakeside Waste Collection (summer) \$143,234
- Provision for additional curbside collection services (winter and summer) \$138.084
- Lakeside Waste Collection (winter pilot) \$24,974

These costs are projected to be offset by savings in front-end bin collection of \$187,138 for a net cost of the Service Level Change related to the bin site transition of \$119,154.

In addition, works related to new depot development to support the transition are funded from the 2021 Solid Waste Management Capital Budget and Forecast – project 450108, Bin Transition – Alternative Drop-off Facilities. Depot development is financed from the Solid Waste Capital reserve fund with a total budget of \$850,000. Costs (including staff and consulting time) associated with depot development have totalled approximately \$33,740 to date.

Communications

The removal of the bin sites is a major system change and the transition requires a detailed, supportive communications strategy and continual work with other key stakeholders including cottage associations, marinas, and island residents.

It is noted that staff continue to respond to and meet with Area Municipalities and cottage associations who have shown interest in becoming key stakeholders during the transition process. EngageMuskoka is being utilized to present surveys and relay information regarding system changes or updates. The Project Team is also investigating innovative methods such as videos and better means to communicate the "why" and how this work is part of the greater Waste Strategy.

Service units transitioning to curbside waste collection will receive letters with information on the District's curbside program and dates, etc. for start of the new service. The Project Team will utilize GIS to best determine current users of the bins sites and impacted property owners. Customer Service support will be prepared for correspondence, calls, etc. received with removal of the sites and will work with the Collections Team during the implementation phase.

Climate Change Implications

The District assesses climate implications in all staff reports using the Clean Air Partnership's 'Municipal Climate Lens Tool' to consider climate impacts or benefits associated with any project, program or initiative. The following is a summary of the results.

Climate Considerations Summary: closing unlicensed bin sites provides an opportunity for the District to increase waste diversion rates and reduce greenhouse gas (GHG), particularly through diversion of organic waste from landfill. The Ministry of the Environment, Conservation and Parks identified these sites as a potential risk to human health and the environment as well as being legislatively non-compliant. Removal of bin sites reduces the potential for spills associated with extreme weather events and is more protective of human and environmental health.

Executive Summary

The purpose of this Bin Site Transition Plan 2021 Annual Report (2021 Annual Report) is to provide an update to the Ministry of the Environment, Conservation and Parks (MECP) on the activities undertaken over 2021 as part of transitioning the District Municipality of Muskoka's (the District) unstaffed and unlicensed waste dumpster sites, planned for full abatement by 2023.

Unstaffed dumpster sites, also referred to as "bin sites", have been in operation throughout the District for over twenty (20) years on road allowances, vacant lands, and at commercial businesses such as marinas, without provincial approval (ECAs). They provided a convenient location for waste collection for residents that do not receive curbside collection at their property (e.g., at marinas for residents with water-access properties and on road allowances for residents on private roads inaccessible for waste collection vehicles).

In 2019, the District was formally notified by the MECP that unstaffed, unlicensed bin sites would have to be transitioned to compliant waste collection servicing over a four-year period, with complete abatement by April 2023. To provide adequate opportunity for public consultation and education and to minimize the potential for illegal dumping, bins are being transitioned out of service in a sequential manner as the District consults with communities, gathers information on servicing needs, and implements alternate waste collection servicing. Extensive consultation has involved assessing communities and alternatives for each bin and consulting with various stakeholders within each community to determine the most suitable long-term servicing alternative. By the end of 2020, there were seventy-seven (77) sites still in service.

Sites Transitioned in 2021

In 2021, the following seven (7) sites were transitioned or have been planned for transition by the end of 2021, which will result in seventy (70) sites remaining in service:

Gravenhurst

- Bin Site 18 Clear Road (for Clearwater Lake) is planned to be transitioned to curbside collection in November 2021
- Bin Site 33 Hewitt Landing will be transitioned to either Lakeside Waste Collection or curbside collection following consultation with the community (spring 2022 servicing)
- Bin Site 70 Riley Lake Road is temporarily being transitioned to Lakeside Waste Collection (potential winter pilot and spring 2022 servicing) while the Housey's Rapids Depot is being developed

Bracebridge

Bin Site 42 – Leech/Pine Lake Road is planned to be transitioned in November 2021 with potential Lakeside
 Waste Collection pilot for winter servicing

Muskoka Lakes

- Bin Site 85 Muskoka Village Harbour (the former Troy Cove Marina, Skeleton Lake Road #2) has been temporarily transitioned to Lakeside Waste Collection pending consultation on long-term servicing
- Bin Site 88 Walkers Point Marina has been transitioned to Lakeside Waste Collection

Huntsville

Bin Site 71 – Rivercove Drive is planned to be transitioned to curbside collection in November 2021

1. Introduction

The District Municipality of Muskoka (District) is responsible for Muskoka's integrated waste management system on behalf of six Area Municipalities, including Township of Georgian Bay, Township of Muskoka Lakes, Township of Lake of Bays, Town of Huntsville, Town of Bracebridge and Town of Gravenhurst. Throughout the District there has historically been an extensive network of unstaffed dumpster sites, referred to as "bin sites", for provision of waste and recycling collection. Bin sites have been in operation throughout the District for over twenty (20) years on road allowances, vacant lands, and at commercial businesses such as marinas, without provincial approval (ECAs). They have provided a convenient location for waste collection for residents that do not receive curbside collection at their property (e.g., at marinas for residents with water-access properties and on road allowances for residents on private roads inaccessible for waste collection vehicles). In 2019, the number of bin sites throughout five (5) of the Area Municipalities totalled eighty-eight (88) (noting that there are no unsupervised bin sites in the Township of Lake of Bays).

In 2019, the District was formally notified by the MECP that unstaffed, unlicensed bin sites would have to be transitioned to compliant waste collection servicing over a four-year period, with complete abatement by 2023. In order to provide adequate opportunity for public consultation and education and to minimize the potential for illegal dumping, bins are being transitioned out of service in a successive manner as the District provides alternate waste collection servicing.

As a result of on-going operational challenges and the COVID-19 pandemic, the MECP supported the District's proposal in 2020 to provide an annual Bin Site Transition Plan which details a summary of bin site removals and mitigation plans carried out for that year as well as the plan being proposed the for the following year. The Bin Site Transition Plan will now be provided as an annual report to the MECP as the extent of works and consultation required to transition over eighty (80) sites is extensive. The first Bin Site Transition 2020 Annual Report (2020 Annual Report) was submitted to the Ministry in November 2020. By the end of 2020 there were seventy-seven (77) sites still in service (36 year-round, 28 summer, and 13 winter).

The purpose of this Bin Site Transition Plan 2021 Annual Report (2021 Annual Report) is to:

- Provide an update on bin sites that have been transitioned to alternate servicing to date;
- Describe other supporting activities and operational changes undertaken by the District between October 2020 and September 2021 to support the bin site transition;
- Propose bin site transition activities to be undertaken in 2022; and
- Describe how bin site transition activities will continue to be reported to District Council, the public, impacted communities, and the MECP.

2. 2021 Overview

2.1 Impact of COVID-19 on District Waste Operations

Throughout the ongoing COVID-19 pandemic, the District's priority continues to be the maintenance of waste collection services, protection of the health of essential workers, and the needs of their community. Significant municipal resources were/are required to ensure continuity of public services and the protection of the public and employees. COVID-19 related behaviour changes (e.g., increased working-from-home, school closures, and seasonal residents arriving in Muskoka earlier and staying for longer periods of time) has increased waste tonnages and increased pressure on the District's waste system.

2.2 Bin Site Monitoring Program

In 2020, a plan was put forward to the MECP outlining a commitment to increase monitoring and servicing of the bin sites in order to keep these locations in service. Monitoring of the sites continued in 2021 throughout the District with additional staff and resources allocated to ensure inspections continued and illegal dumping was addressed as per commitments made to the MECP at the outset of the pandemic. The dumpster sites are visited on a regular basis by staff and conditions such as dumping and signage are documented. Photos are also taken to document the condition of the sites. A monitoring database is maintained. It is noted that illegal dumping continues to be problematic especially over the weekends.

2.3 Summer Curbside Collection Impacts

The District continued to experience unreliable completion of its weekly curbside collection program for waste, recycling and organics throughout 2021 – most notably in the summer months.

Specifically, the District's curbside collection contractor experienced a shortfall of approximately 20-30% of the required drivers and challenges managing increased volumes of material with shifting residential behaviour due to the pandemic. Issues with curbside collection have impacted plans for furthering the bin site transition. Over the summer months, staff's priority shifted to ensure continuity of curbside service. In addition, the immediate transition of communities utilizing bin sites to curbside service was delayed in order to maintain service levels, provide relief to customer service staff, and support the District's larger waste management goals (e.g., minimizing illegal dumping).

Notwithstanding these challenges, the expansion of the District's curbside collection program remains the most desired waste collection alternative being assessed as it provides the most convenient and most effective service due to economies of scale. As timely and reliable curbside collection service resumes, communities with existing bin sites may be transitioned to curbside collection service, where appropriate.

3. Bin Site Update

3.1 Determining Alternate Servicing

In the August 2021, District staff brought Report PW-10-2021-6 to Engineering and Public Works Committee (EPW Committee), summarizing the approach that has been developed to assess and prioritize alternative waste collection servicing for communities (https://muskoka.civicweb.net/filepro/documents/37483). This approach is based on extensive consultation the District has undertaken since 2019 with cottage/lake associations, residents and communities throughout the District during bin site transitions. Specifically, the following were identified as primary considerations when considering waste collection alternatives:

- Convenience for residents and service level;
- Potential for diversion;
- Cost effectiveness; and
- Whether it is an MECP approved long-term, sustainable level of servicing.

As documented in the August 2021 staff report, generally, curbside collection, Lakeside Waste Collection and new drop-off depot(s) are recommended as servicing options in that order. As a general guideline, the District and GHD collect community-specific information and review the following considerations in order the determine the suitable waste collection for that community:

Curbside Collection

- Considerations for instituting curbside collection:
 - ability to extend existing routes
 - condition of private/cottage roads
 - potential for common collection points
 - number of households to service
 - practicality of a number of individual roadside bins in one location (i.e., landing parking lot, road allowance, etc.).
- Advantages of curbside collection:
 - convenience as waste can be left in roadside bins for collection during the week
 - potential for increase in diversion
 - the most cost-effective service type due to economies of scale
 - no additional capital infrastructure required.

Lakeside Waste Collection

- Consideration for instituting lakeside waste collection:
 - ability to service larger numbers of island/water access residents at one (1) location that cannot be serviced by curbside collection
 - allows for collection at the shoreline but is less convenient as residents must bring waste during a window of time
 - generally, a summer-only service option but may be piloted to determining the viability of this service during the winter months
 - although dependant on the number of users, more expensive than curbside service per unit (due to the reduction in economies of scale).
- Advantages of lakeside waste collection:
 - "made in Muskoka" solution with the ability to offer shoreline/lakeside collection (i.e., residents don't need to load garbage in their vehicles for transport)
 - flexibility to expand and adjust the collection location and times as required based on usage/need
 - the program is approved by the MECP
 - no additional capital infrastructure required.

- Considerations for instituting drop-off depots:
 - areas with a greater number of residents to service where curbside collection is not an option (generally greater than 100 serviced units)
 - community consultation indicating need and/or willingness to host
 - areas with longer drive times to existing transfer station(s)
 - requires initial capital investment, on-going maintenance and operating budget for staffing, haulage, environmental monitoring, etc.
 - requirement for significant lead time due to required municipal and provincial approvals even on existing waste sites (land use planning, environmental studies, etc.)
 - potential traffic impacts
 - addressing concerns of neighbours.

- Advantages of new drop-off depot locations:
 - ability for longer service hours than Lakeside Waste Collection
 - potential for flexible weekday and/or winter hours
 - provision of an additional service to a community as a whole not just the existing bin site users (i.e. supplemental drop-off to all residents in the area).

3.2 Sites Removed or Planned for Removal in 2021

The focus for 2021 has been on continuing the community consultation initiated in 2020 to determine suitable alternatives and consult key community stakeholders on those alternatives in consideration of the above methodology. In addition, the District's waste collection contractor visited a number of bin sites to investigate the potential of servicing units with curbside collection. Many private/cottage roads can be serviced with the current collections fleet and through the use of individual/roadside bins at landings and new common collection points.

As a result of these efforts, seven (7) bin sites have been removed in 2021 or have been identified for transition by the end of 2021 (see Table 3.1). A full listing of the bin sites for each municipality and their status can be found in **Error!**Reference source not found..

3.3 Lakeside Waste Collection

Lakeside Waste Collection is a 'made-in-Muskoka' convenient garbage disposal alternative from boat-to-bin. This method of waste collection was piloted in three communities in the Township of Muskoka Lakes in 2020 (Foot's Bay, Beaumaris and Windermere). As a result of the successful pilot and the positive feedback received from those communities, the Lakeside Waste Collection Program has continued and expanded to two additional locations where the property owners requested the bin be removed in spring 2021 (Skeleton Lake and Walkers Point Marina). Currently Lakeside Waste Collection if offered every Sunday during the summer at the following locations:

- Lake Joseph McDonald Road (Foot's Bay)
- Skeleton Lake Public Launch

- Skeleton Lake Muskoka Village Harbour
- Lake Rosseau Parker's Marina (Windermere)
- Lake Muskoka Walker's Point Marina
- Lake Muskoka Church Dock Road (Milford Bay)

The Program is intended for island and water-access properties in the Township of Muskoka Lakes and not intended for residents who receive Curbside collection. The District has an established website for the Lakeside Waste Collection that provides details on the collection schedule, what items are accepted for collection and to seek feedback from residents utilising the Program: https://www.engagemuskoka.ca/lakeside-collection. The District has continued to receive positive feedback on the Lakeside Waste Collection Program, particularly regarding the service operators who have been professional and courteous towards residents.

3.3.1 Winter Servicing

Consideration is being given to the potential use of Lakeside Waste Collection for winter servicing in areas not accessible by curbside collection vehicles or in areas where the number of households requiring servicing is too great to make a common collection point viable. A pilot will be undertaken this winter to service some communities transitioning in 2021 (Riley Lake, for example). From this pilot, information will be gathered on the viability of this model for other areas with significant number of year-round residents requiring winter service with longer than average drive times (>25 minutes) to a licensed waste facility. Considerations will include weather-related service impacts, communication to residents, and cost of service.

3.4 Development of New Supervised Drop-off Depots

As noted in Section 3.1, the establishment of new supervised drop-off depots is one of the alternatives being assessed for some communities. Considerations for new depots (as outlined above) include the number of households requiring servicing and drive times to an existing waste facility. Specifically, the following are locations where planning and design of new supervised drop-off depots has begun or is planned for further consultation in 2022:

- Housey's Rapids Depot
- Minor's Bay on Go Home Lake
- Skeleton Lake (pending further community consultation)
- Nine Mile Lake
- Beaumont Drive (to service Browning Island and east Lake Muskoka households) (requires further approval from the Town of Bracebridge)

4. Community Engagement

The following is provided as an overview of the communication and consultation activities that were undertaken between October 2020 to September 2021 to support the bin site transition. Given the many years that the bin site has provided waste collection service, consultation and communication is critical to ensure that alternate waste servicing reflect the needs, interests and concerns of communities.

4.1 District-Wide Consultation and Communication

District-wide communication and consultation with residents has been undertaken primarily through the District's EngageMuskoka online engagement platform. The EngageMuskoka Bin Site Transition page (https://www.engagemuskoka.ca/bin-site-transition-plan) includes project background, a timeline of the project, key reports and documents, and news updates.

A survey called "Have Your Say" was established in early 2020 and remains live on the EngageMuskoka Bin Site Transition page. The purpose of the survey is to understand how bin sites are used by residents, identify cottage associations for further consultation, and obtain feedback to be considered as part of the alternate servicing study. In 2021, an additional 10 respondents have responded to the "Have Your Say" survey.

Updates regarding services at bin sites, available community surveys, Lakeside Waste Collection schedules and the 2021 consultation plan was communicated to the public through the website: https://www.engagemuskoka.ca/bin-site-transition-plan.

4.2 Updates to District Council and Engineering and Public Works Committee

The District continued to provide updates at the District Council and Engineering and Public Works Committee meetings. Presentations and staff reports regarding the bin site transition program were made at the following meetings:

4.3 Consultation with Individual Bin Site Communities

As discussed in Section 3.1, throughout 2021 there has been a strong focus on continuing to consult with communities on long-term waste servicing alternatives to facilitate transition of sites in 2021 and 2022. For most communities, bin site hosts and cottage/lake associations are consulted first to provide an introduction and discuss potential long-term servicing alternatives. As discussed in Section 3.1, generally, curbside collection, Lakeside Waste Collection and new drop-off depot(s) are recommended as servicing options in that order. In addition, some communities may be directed to existing drop-off locations. Determining a path forward in regard to winter servicing has been more complicated due to the unknown number households requiring servicing. Working with residents directly on arrangements (which is standard practice for winter service) has been the path forward thus far. Most often, curbside collection facilitated with common collection points, potential winter Lakeside Waste Collection or drive to an existing waste facility are the viable options.

The approach for consulting residents who use the bin sites is determined in collaboration with bin site hosts and/or cottage/lake associations. For some bin sites, community surveys are developed in collaboration with bin site hosts and/or cottage/lake associations, to consult residents on servicing alternatives. If curbside collection is found to be a viable alternative, most often communities are amenable to this alterative and have forgone a survey or further consultation.

In 2021, the District published five (5) community surveys to seek feedback from residents on servicing alternatives in the following communities. A summary of the survey results for each of the above noted communities is provided on the EngageMuskoka website (https://www.engagemuskoka.ca/bin-site-transition-plan), attached in **Error! Reference source not found.**, and summarized below:

Kahshe Lake – residents that use bin sites at Dennes Marina (Bin Sites 20, 21 and 22), South Kahshe Lake Road (Bin Site 79), and Rockhaven Resort (Bin Site 72) were asked for their feedback on three waste servicing options: 1) Lakeside Waste Collection, 2) a new waste depot at one of the District's historic waste sites located south of Kahshe Lake, or 3) using an existing Depot. It was noted in the survey that curbside collection could be extended to residents on South Kahshe Lake Road. The community survey was developed in consultation with the Kahshe Lake Ratepayers Association (KLRA) and distributed by the District and KLRA. The District received 141 responses to this survey, with 90% of respondents preferring Lakeside Waste Collection.

- Clearwater Lake residents that use bin site on Clear Road (Bin Site 18) were asked for their feedback on four waste servicing options: 1) Lakeside Waste Collection, 2) Curbside Collection, 3) Curbside Collection via Common Collection Point at the current bin location or 4) use of the Existing District Transfer Station or Depot. The community survey was developed in consultation with Clearwater Lake Property Owners Association (CLPOA) and distributed by the District and CLPOA. The District received 59 responses to this survey with 51% of respondents preferring Curbside Collection via Common Collection at the current bin site.
- East Lake Muskoka island and water access residents that use the bin sites located at Allport Marina, Pride of Muskoka Marina, Spirit Bay Marina (Bin Sites 3, 64 and 39) were asked for their feedback on four waste servicing options: 1) Lakeside Waste Collection at all three Marinas (for an equal amount of time), 2) Lakeside Waste Collection at Browning Island Public Docks (for a longer period of time), 3) Establishment of a new Water-Access Waste Depot on Beaumont Drive or 4) use of the Existing District Transfer Stations. The community survey was developed in consultation with marina owners and Muskoka Lakes Association (MLA) and distributed by the District and marina owners. The District received 146 responses to this survey with 42% of respondents preferring a New Waste Depot at Beaumont Drive.
- Walker's Point and Beaumaris island and water access residents that used the bin sites formerly located at Walker's Point and the Beaumaris Yacht Club (BYC) (Bin Sites 88 and 7) were asked for their feedback on three waste servicing options: 1) Lakeside Waste Collection at Church Dock Road public dock and Walker's Point Marina, 2) Establishing a New Waste Depot on Walker's Point Road or 3) use of the Existing Transfer Stations. The community survey was developed in consultation with marina owners and MLA and distributed by the District and marina owners. The District received 46 responses to this survey with 72% of respondents preferring Lakeside Waste Collection. Several suggestions were made by respondents on how the current Lakeside could be improved for the long-term.
- Nine Mile Lake residents that use the bin site located at Nine Mile Marina (Bin Site 53) were asked for their feedback on three waste servicing options: 1) Curbside Collection for road-access residents and Lakeside Collection of water-access properties, 2) Curbside Collection for road-access properties and a New Depot, or 3) use of the Existing Transfer Stations. The community survey was developed in consultation with the marina owners, a representative of the water-access community and distributed by the District and the marina/community partner. The District received 130 responses to this survey with 92% of respondents preferring a New Depot combined with Curbside Collection.

5. Proposed 2022 Activities

The activities proposed for 2022 are described in Table 5.1. This includes twenty-eight (28) bin sites proposed to be transitioned in 2022. Recognizing the District's EPW Committee's October 2019 direction to provide affected residents adequate notice and public education in advance of transitioning bin sites, Table 5.1 also describes the transition planning and consultation activities proposed to continue in 2022.

A number of factors were considered as part of identifying bin site transition activities proposed for 2022:

- Consultation undertaken to date on long-term servicing alternatives with bin site hosts, lake/cottage associations, and/or residents who use the bins noting that there are a number of communities already actively engaged and seeking resolution.
- The approach for assessing and prioritizing alternative waste collection servicing described in EPW Staff, as described in Section 3.1
- Additional effort required to assess and/or implement alternate waste collection services. For example, Lakeside
 Waste Collection for water-access residents requires further assessment, costing and piloting to assess its
 effectiveness. Similarly, new supervised depots require extensive design and approvals (including potential land
 use approvals such as Official Plan and/or zoning amendments) prior to construction.
- Ability of the District to provide consistent and reliable curbside collection in light of existing service challenges with the existing contractor.
- Level of environmental risk as identified in the Risk Mitigation Assessment.
- Geographical proximity of bin sites to each other. Transitioning bin sites in the same community at the same time
 is preferred to recognize economies of scale, minimize confusion and allow for consistent and targeted
 messaging.

We understand that approximately 230 water-access households on Kahshe Lake use the bin sites at Dennes Marina (office location) and Rockhaven Resort or used sites formerly at the Dennes Marina (dock location) or Nagaya Road landing (properties shown in yellow on the map opposite). Approximately 40 households on South Kahshe Lake use the bin site on South Kahshe Lake Road (shown in green on the map opposite) and approximately 40 residents on Larroger Road and Deep Bay Road use the bin site on Riley Lake Road (shown in orange on the map opposite).

The District is currently investigating if curbside collection can be extended along South Kahshe Lake Road for households highlighted green. For households on Larroger Road, a new depot is currently being developed at the former Houseys Rapids waste site



Option 1: Mobile Landing Collection (Rockhaven or Dennes Marina)

With this option:

- Residents would bring their garbage and recyclables to a special waste collection trailer (see example photo) or collection vehicle parked at a landing location (such as Rockhaven or Dennes Marina).
- The collection trailer/vehicle would be parked and supervised at a location accessible by boat for a pre-determined window every week during the summer (e.g. Sunday evenings from 2:00 to 6:00 p.m. or 4:00 p.m. to 8:00 p.m.).
- If residents require waste disposal outside of the collection window or have bulky items, they would need to visit a District transfer station such as the Beiers Transfer Station or drop-off depot.









Option 2: Establish a New Waste Depot at former Morrison Transfer Station or former Sparrow Lake Route D Transfer Station

Two District-owned historic waste sites have been identified as potentially suitable for a new waste depot (see map opposite). This alternative would involve constructing a supervised waste depot on Canning Road at Baseline Road (former Sparrow Lake Route D Transfer Station) or on Southwood Road at Baseline Road (former Morrison Transfer Station):

- Both locations are located south of Kahshe Lake, less than 5 minutes from Highway 11
- Although not accessible by boat, the new depot would have longer hours of operation than mobile landing collection (e.g. Sundays from 12:00 to 8:00 pm and potentially Saturday/weekday hours).
- The depot would be for collection of household waste only (i.e., bagged garbage and recyclables), would be fenced, and would be supervised during the hours of operation as per provincial regulations.
- If residents need to dispose of waste outside of the hours of operation or have bulky waste, they would need to visit a District transfer station such as the Beiers Transfer.


Kahshe Lake Community Survey Summary

This community survey was undertaken to seek feedback from residents who use the bin sites around Kahshe Lake on long-term waste servicing options for this community.

- The survey was developed in consultation with the Kahshe Lake Ratepayers Association (KLRA) and made available on EngageMuskoka (https://www.engagemuskoka.ca/bin-site-transition-plan/survey-tools/kahshelake)
- The survey was promoted by the District and the KLRA via:
 - The January 17, 2021 KLRA newsletter
 - Email from District on February 12, 2021 to approximately 230 residents who registered on EngageMuskoka and identified as a user of one of the bins sites around Kahshe Lake
- 141 responses received:
 - Approximately half of respondents are water access households
 - Remaining respondents were residents of South Kahshe Lake Road, Larroger Road, or receive curbside waste collection



Yellow Properties: Water-access households that use the bin sites at the Dennes Marina, Rockhaven Resort or Nagaya Road landing (approx. 230)

Green Properties: Households that use the bin site on South Kahshe Lake Road (approx. 40 households)

Orange Properties: Households that use the bin site on Riley Lake Road (approx. 40 households)

The survey asked for feedback on two waste servicing options:

Mobile Landing Collection

- Residents would bring their garbage and recyclables to a special waste collection trailer or collection vehicle parked at a landing accessible by water, (such as Rockhaven or Dennes Marina, subject to landowner permission).
- The collection trailer/vehicle would be parked and supervised at a location accessible by boat for a pre-determined window every week during the summer (e.g. Sunday evenings from 2:00 to 6:00 p.m. or 4:00 p.m. to 8:00 p.m.).



New Waste Depot

- A supervised waste depot would be constructed at one of the District's historic waste sites (former Morrison Transfer Station or former Sparrow Lake Route D Transfer Station), both of which are located south of Kahshe Lake, west of Highway 11 (see map).
- Although not accessible by boat, the new depot would have longer hours of operation than mobile landing collection (e.g. Sundays from 12:00 to 8:00 pm and potentially Saturday/weekday hours).



Summary of Survey Results



A large majority of respondents prefer the mobile landing collection option. Several suggestions were made to consider if this option is implemented.

This result was consistent regardless of where the respondent lived in the Kahshe Lake community.

Advantages of mobile landing collection:

- Accessible by boat, no requirement to use a car
- Convenient and supervised
- Almost replicates the current disposal system
- Less fuel pollution

Comments/considerations for mobile landing collection:

- Concerns that people will leave garbage at the mobile collection site on non-collection days
- Request for mobile site at South Kahshe Lake Government Dock
- Concerns that road access properties will use the mobile collection
- Concern that collection window is too limited for the number of properties

Advantages of new waste depot noted by respondents:

- More accessible hours
- Less risk of unsupervised dumping
- Distance of waste from the Lake

Additional Comments Regarding Mobile Landing Collection Option:

Like

- Accessible via water
- Convenient
- No requirement to use a car
- Supervision of what is being disposed of (which will restrict residents dumping items that should be dropped off a waste depot
- Clean
- Holds households accountable for their garbage

Dislike

- Restricted/limited disposal time
- High potential for boat congestion
- No way to determine whether individuals dropping off garbage are water access properties
- Too small for the number of properties
- People will have to store their garbage until collection day (which may attract bears around the cottages)

Additional Comments Regarding New Waste Depot Option:

Like

- It is southbound from Kahshe Lake, which allows you to access it when leaving the cottage
- It is supervised
- Uses a historic waste disposal site rather than a new location
- Increased capacity for garbage

Dislike

- Does not provide any benefit for water access taxpayers
- Too far for boat access properties (not convenient)
- Requires double handling of garbage from boat to car
- Concerns it would result in illegal dumping at the former bin site locations
- Easier and faster to go to Beiers Road
- Concerns related to line-ups for disposal







This community survey was undertaken to seek feedback from residents around Clearwater Lake, who use the bin site on Clearwater Road on long-term waste servicing options.

- The survey was developed in collaboration with Clearwater Lake Property Owners Association (CLPOA) and made available on EngageMuskoka (https://www.engagemuskoka.ca/bin-site-transitionplan/survey tools/clearwaterlake)
- The survey was promoted by the CLPOA to its members and by the District via email to approximately 21 residents who registered on EngageMuskoka.
- 60 responses received from 57 households on the following roads:
 - Clear Road 3
 - Duggan Trail 4
 - Hillsdale Road 11
 - Lawrence Drive 24
 - Sanderson Road 18
- Approximately half of respondents are summer residents and half are year-round residents



The survey asked for feedback on four waste servicing options:

Option 1: Mobile Truck Collection

 Residents would be required to bring their household garbage and recyclables to a collection vehicle parked on Clear Road once per week. Collection would be available for a predetermined window every week, such as for 2 hours every Sunday.



Option 3: Curbside Collection – Common Collection Point at the Current Bin Location

Residents would purchase bear-proof curbside bins. All bins would be installed in a central location close to the existing bin on Clear Road, subject to finalization of agreement between CLPOA and the current property owner. Residents could bring their waste to their bin any time during the week. Only year round/off season residents would receive collection in the winter. The District would pick up weekly as part of its regular curbside collection route. Residents would need to take items to a District transfer station.

Option 2: Curbside Collection

Residents would receive the District's weekly curbside collection service.
 Residents would be able to use a standard garbage can, bags, or purchase a bear-proof curbside bin.

 Waste would be collected from the end of driveways once a week on the day of collection. Residents would need to take bulky items to a District transfer

 In some cases, bear-proof curbside bins may be installed at or close to the current bin site location, subject to an agreement between CLPOA and the current proper owner.

Option 4: Use Existing District Transfer Station or Depot – Beiers Transfer Station or Housey's Rapids Depot (in development)

PResidents would use one of the District's existing transfer stations or depots. Beiers Transfer Station is located approximately 25 minutes north of Clearwater Lake. In addition, a new depot is in development in Housey's Rapids, approximately 15 minutes north (see map).






Number of Respondents by Location



Percentage of Respondents by Marina




Summary of Survey Results









About the Survey

This community survey was undertaken to seek feedback for long-term waste servicing options for island/water access households located on and around Nine Mile Lake and Bastedo Lake that use bin sites (dumpsters) located at the Nine Mile Lake Marina

- At the Direction of the Ministry of the Environment, Conservation and Parks, unlicensed bins (dumpster sites) must be removed.
- The survey was developed in collaboration with Nine Mile Marina and made available on EngageMuskoka (https://www.engagemuskoka.ca/bin-site-transitionplan/survey_tools/ninemilelake).
- The survey was promoted by the Nine Mile Marina owners to their customers and by the District via email to approximately 44 residents who registered on EngageMuskoka.



About the Survey

The survey asked for feedback on three waste servicing options:

Option 1: Curbside Collection for Road-Access Residents and Lakeside Collection for Water-Access Properties:

With this option, curbside collection would be extended for all roadaccess properties located on Summit Road, Eckford Road and 1210 Nine Mile Lake Road. Where a road is not accessible by a waste collection vehicle, residents would use a designated common collection point (See Map)


Residents without curbside collection would bring their garbage and recyclables to the Nine Mile Lake public dock, where a waste collection vehicle would be parked for collection.

Option 2: Curbside Collection for Road-Access Properties and New Depot:

With this option curbside collection would be extended for all roadaccess properties located on Summit Road, Eckford Road and 1210 Nine Mile Lake Road. This alternative would also involve constructing a supervised waste depot on Southwood Road open to all water-access and road-access residents.

Although this option would not be accessible by boat, the new depot would have longer hours of operation than Lakeside Collection.


Two District-owned historic waste sites have been identified as potentially suitable locations – the former Wood Dump or former Torrance Transfer Station (see Map).



Option 3: Using the Existing Transfer Station


With this Option, all residents would be required to transport their household garbage and recyclables to an existing transfer station, such as the Eveleigh Transfer Station in Port Carling or the Beiers Transfer Station located in Gravenhurst, south of Nine Mile Lake.


Survey Respondents



- 130 responses were received
- Respondents were asked to provide their Muskoka address:
 - 58% of respondents are water-access residents on Nine Mile Lake
 - 16% of respondents reside on Summit Road
 - 9% on 1210 Nine Mile Lake Road
 - 9% on Eckford Road
 - 6% on Nine Mile Lake Road
 - 2% did not provide their Muskoka address.


Summary of Survey Results – Water Access Residents on Nine Mile Lake






- 75 water access residents responded to the survey
- 95% preferred a New Depot combined with Curbside Collection.
- 66 of water-access residents are summer only residents, 7 are year-round residents and 2 did not specify.

Summary of Survey Results – Road Access Residents around Nine Mile Lake





- 54 road access resident responded to the survey
- 89% of road access residents preferred the New Depot combined with Curbside Collection.
- 25 road access residents are summer only residents and 29 are year-round residents.
- Seasonality provided in individual responses will be used to finalize common collection point locations.

Comments Regarding Common Collection Points:Like

As a road-access property Curbside Collection is suitable

Dislike

- Common collection for road-access residents will be an invitation for boat-in cottagers to drop their garbage off there, which could result in smaller dumps at these locations
- Potential for people to dump garbage if they do not want to drive to the transfer station
- Common-collection points could be an eyesore and may attract bears
- For road-access residents bear bins are expensive and are in short supply

Questions

- For curbside-collection, common collection points and the new depot would there be recycling?
- What is the difference between having common collection points and having the bins remain locked and opened for a supervised time frame?
- Will road access cottages/homes receive roadside pick-up at the point at which the dumpsters are removed from the current site?
- Is the Township taking responsibility to clear non-municipal roads getting curbside collection during winter or are residents required to clear roads? Will my taxes go up because of this?
- How many bear bins will be at the common collection points?
- How will dumping be prevented at the common collection points?

Comments Regarding Lakeside Waste Collection:

Like

No responses provided

Dislike

- The Lakeside Collection windows is too limited for the number of water-access properties
- There would be boat congestion at the Marina which is a safety concern for water-access residents
- Having to make a special trip to drop off garbage on a specific day to meet the Lakeside Collection window
- No alternative if the Lakeside Collection window is missed
- It will disadvantage the marina as residents won't have time to stop and pick up supplies in the short window
- If the Lakeside Collection window is missed it is a 45-minute drive to the transfer station
- There is limited public space at the marina and the garbage collection vehicle would take up a lot of space. This is the only access point for the entire lake and would cause disruption to day users
- The public boat launch would not be available for day users during this time

Questions

• If you miss the Lakeside Waste Collection pick-up, what options do you have?

Comments Regarding a New Waste Depot:

Like

- This option has added flexibility and the potential sites for a new depot are close for water-access residents
- This is the most accommodating and environmentally efficient system
- The longer hours are better for water-access residents. Would suggest a weekday drop-off time as well to avoid everyone having to go on the same day
- Supervision at the depot will address unauthorized dumping
- There wouldn't be congestion at the marina as there would be if Lakeside Collection was implemented
- The new depot would be available for all four seasons
- Provides a place for day users and campers to also drop of waste
- Suitable for Nine Mile Lake and Bastedo Lake residents.

Dislike

- Drop-off being limited to one day only
- Having to transport garbage in a vehicle
- Creating a new waste depot is not environmentally friendly

Questions

- For the 2022 season, can we ask that the bins currently at Nine Mile lake be temporarily relocated to the proposed transfer stations on Southward Road while construction and permitting of the new facility is being completed.
- Will there be a dumping fee every time we use the new depot?
- For the New Depot is it possible to have it open by 9 a.m. on Sundays for residents who leave in the morning?

Comments Regarding Use of an Existing Transfer Station:

Like

This option costs the least. If there one any closer it would be better.

Dislike

- Extremely inconvenient for all residents
- Will not work for day users and renters and will result is illegal dumping
- It is a waste of individuals time to have to drive garbage so far away
- Not very environmentally friendly
- Out of the way for most residents going home
- Don't want to put garbage in my vehicle
- This option will mean I get no services for my taxes
